

# Confrontations-Despicable Performance

## Opportunists in North America Jump out to Rescue Their Indian Friends

Continued from PCDN, Vol. 6, No. 104

The following is a continuation of the article "Unsolicted Confrontations - Despicable Performance" in PCDN. Previous portions were printed in PCDN, Vol. 6, Nos. 91, 92, 93, 94, 95, 97 and 104.

31. Following the fascist style of Jack Scott, and in the tradition of the Khrushchovite revisionist splitter in Montreal who is one of the architects of the "Communist" League, an anarcho-fascist sect, the "Communist" League paraded a slanderous article entitled "CP(M-L) Attacks" in Montreal in September 1975. The article, which the "IPANA opportunists further exposed themselves. Talking about the reasons for organizing the "IPANA demonstration, the "CPL provide their own self-exposition:

1. "to denounce the fascist dictatorship in India"

2. "to commemorate the 25th anniversary of Indian independence from British colonialism" (60)

The "IPANA opportunists hesitated to state clearly that they were there for two reasons, that is to "mourn the loss of bourgeois democracy" and "to commemorate the 25th anniversary of Indian independence from British colonialism", but their friends in "CPL" did not. The anarcho-fascist sect proceeded to "expose" CPC(M-L) but did not expose the police. The rest of the article presents the lies of the "IPANA opportunists but with the added anti-communist venom of "CPL". They write: "In an attempt to avoid provocation, the IPANA demonstrators stepped aside to make room for the "CPC(M-L) goes to pass. But the thugs were obviously prepared for a fight. The cotton wools plugged in their noses and carried 2, 4's. They began attacking women and children, and when the women fought back, the goons shouted chauvinist abuses at them. When the IPANA members stepped forward to help out their comrades, the "Party" goons went wild and began hitting people indiscriminately. With their 2, 4's they left many people with head, arm and back injuries. An eight-year-old girl received a blow on the head. Two other people were badly injured: one of them was on the brink of death for several hours. As for the Vancouver police, not only did they not intervene against the CPC(M-L)'s fascist aggression, but they also refused to call an ambulance to transport the injured. This attitude is not only that of the police but the real fascist provocateurs the same way in all capitalist countries." This is just one lie after another. 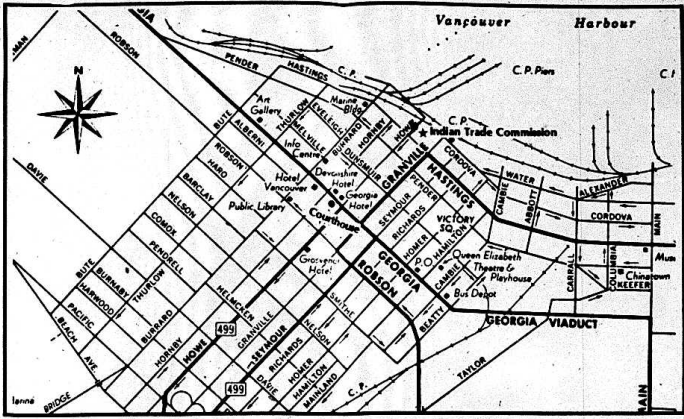

Jack Scott and others raising the question of police is that prior to August 14, 1976, all of these opportunist sects and individuals have been accusing CPC(M-L) of being "violent" and "provoking police". But now they have changed their tune. Now CPC(M-L) and the police have "gotten together". This slander against CPC(M-L) concretely shows that the opportunists are fascists, an unprincipled group, who will go to any lengths to take the side of the state against CPC(M-L). Over 2,000 arrests of CPC(M-L) comrades have taken place. These arrests continue. There have been no rare occasions when a member or supporter of CPC(M-L) is not in jail. Over 25 CPC(M-L) comrades have been deported. Many, including Hardial Bains, cannot get their jobs. Many professions are thrown out their jobs. All this, the opportunists dismiss by their fascist slander that CPC(M-L) "provokes the police". And, now of course, when they are being exposed daily, the opportunists have to come out with their monstrous lie that police "support" CPC(M-L).

4. We print a map here for our readers and show that any "short-cut" between the office of the Indian trade commissioner to the courthouse or vice versa is actually a longer route as it is a straight route from the courthouse to the Indian trade commissioner's office. True to their fascist nature, En Luttel has to concoct lies to serve their counter-revolutionary designs. So they are caught. Just as the Toronto and Buffalo fascists are caught in their jobs. All this, the opportunists dismiss by their fascist slander that CPC(M-L) "provokes the police". And, now of course, when they are being exposed daily, the opportunists have to come out with their monstrous lie that police "support" CPC(M-L).

5. What lessons did they draw? That they have to prepare a better provocation and instigate revolutionary activity.

6. On their yellow journal (77), these opportunists wrote a slanderous article against HGP(M-L), full of racist and chauvinist invective, in order to attack the Indian communist revolutionaries resident abroad. These anti-communists rave:

7. There has been no statement issued by CPC(M-L) or HGP(M-L) concerning the tour of Mary Tyler. In fact, the tour of Mary Tyler is another example of "IPANA opportunists" in spite of the fact that they are not their own organizations. They went on their own to oppose the line of Mary Tyler. Finally, HGP(M-L) and its mass organizations are not opposed to bourgeois democrats carrying out propaganda against fascist dictatorship. On the contrary, it is "IPANA opportunists who are opposed both to the bourgeois democratic revolution and the proletarian revolutionary line. In fact, they think again if they want to come up with some instance of "IPANA opportunists being attacked by CPC (M-L) or HGP (M-L) and its mass organizations.

8. This is a repetition of the lie which "CPL started about HGP (M-L) having no 'real existence in India'. It was never organized there and it has no mass support. It is the leadership of Comrade Charu Mazumdar considered it as part of CPC (M-L), an integral part.

9. This precisely applies to En Luttel. This is the manner in which En Luttel operates. Hundreds of examples of their lies can be given.

10. This also applies to En Luttel. Only En Luttel has the declared aim of splitting, breaking up and disintegrating the "Marxist-Leninist movement" in Canada and opposing the building of the Party. Hundreds of instances can be given of their splitting activities.

The method of En Luttel and other opportunists is the same: accuse CPC (M-L) of monstrous crimes and create a fog in order to obscure and mystify the issue. Like "CPL" and Jack Scott, they have created boogymen: Hardial Bains, HGP(M-L), HGP(M-L), IWM and others. Instead of clarifying the politics that divide Marxism-Leninism from opportunism, they raise issues about individuals and organizations by concocting slanders. This is the style of police socialism. These opportunists are police socialists. Their main aim is to deprive the working class of its Party, and deprive the Party of its working class mass support so that the state can suppress both the Party and the working class movement. Jack Scott came out to rescue the state when it viciously attacked Comrade Bill Shpikula in the beginning of 1970. "CPL" has played the same role. CPC (M-L) is going to print a detailed dossier about the splitting and wrecking activities of all these organizations and individuals. We call upon our members and supporters to get a copy of the book when it is published.

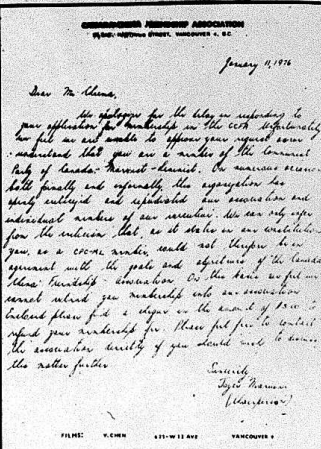

Now let us see what attitude Jack Scott takes towards an East Indian who applied for membership. We reproduce below a letter written by Joyce Marvin to Mr. Cheema, rejecting the application of Mr. Cheema on the grounds that "you, as a CPC (M-L) member, could not therefore be in agreement with the goals and objectives of CCA". Jack Scott signed a cheque sending back the money to Cheema and endorsing the action. Now the question arises: How come Jack Scott did not take the opportunity to smash the "wall" between the East Indian community and its "natural allies"? Secondly, why did he turn this non-antagonistic contradiction into an antagonistic one on page 25 thereof. All this is very clear. Jack Scott hates the policies of armed agrarian revolution. He is raising sideline issues to obscure the real issue. In behaving in such a manner, he is also calling on all reactionaries in the East Indian community to come forward and make an alliance with him. This is a nefarious activity on the part of Jack Scott. HGP (M-L) vigorously denounces this activity. HGP (M-L) calls upon all our members and supporters to firmly denounce this provocative, agent of international opportunism and of the state, who is opposing the armed agrarian revolution in India, the key to unlock the people's democratic revolution and is supporting the attacks of the reactionaries in the East Indian community and the state against the progressive and democratic struggle in the East Indian community.

34. "IPANA opportunists continue with their vicious slandering-mongering in their foul mouthpiece, so-called New India Bulletin, against HGP(M-L) and CPC(M-L) in their July-August issue. The entire issue is literally devoted to slandering CPC(M-L). This is their main goal. On page 25 thereof is an item entitled "Resolution of Montreal unit of IPANA on the Attacks by the HGP". It is interesting to note here that while the pink leaflet which is distributed all across North America and elsewhere is entitled "Fascist Attack by CPC(M-L) Disrupts IPANA Demonstration", the "Montreal Unit" makes no mention of CPC(M-L). This resolution is very interesting, indeed, as it further looks the conspiracy of "IPANA opportunists against HGP(M-L) and its mass organizations. The resolution "condemns the deliberate attack on its demonstrators in Vancouver on August 14, 1976" by "anti-people toughs of the Hindustani Ghadar Party."

The "attacks" were "particularly contemptible and malicious in that children and women were the first target of attack."

This "Montreal Unit" of "IPANA" is centered around the Khrushchovite revisionist splitter who is past master in lying and trickery. He also is a feudalist, national chauvinist and intriguer of the first order. The manner in which the "resolution" of the "unit" is written, speaks volumes about the nature of this individual. Let us give an example. The resolution says: "Inter-Asian, inter-race and straightforward lying. This 'unit' claims that the 'attack' was particularly contemptible and malicious in that children and women were the first target of attack. Why is this lie being repeated over and over again by all the opportunists? To grasp this, one has to grasp the feudalist and chauvinist nature of this splitter and his ability to intrigue."

This feudalist purveyor put women in front so that when their provocation was repulsed, they could begin harping about attacking women. It is this feudalist folio which is his reactionary tradition well. There is an ancient story extremely popular amongst the Indian masses that when one party was at war with another, was unable to defeat one of the warriors of the Karvas, the slave-master and reactionary Hindu ideologue Krishna advised Pandvas to find someone who would make it possible for this warrior named Bhishma to fight. As the story goes, warrior Bhishma, according to his moral code, would not fight with women. So, the Krishna, the crooked opportunist, found a person by the name of Sikandi in the army of Pandvas, who was a woman in his previous life. So Krishna advised Arjuna, one of the warriors of Pandvas, to put Sikandi in front of him and then attack Bhishma. So, Arjuna put Sikandi in front of him the next day and attacked Bhishma. Bhishma, abiding by his moral code, instead of coming forward to fight, was unable to do so. In the end, Arjuna penetrated the back of Bhishma. Taking a cue from his reactionary background, this feudalist intriguer worked out the plan and put women in front to make provocations against the IWM demonstrators. But IWM demonstrators were no backward individuals who they do not consider women as being in any way unequal to men. There is no distinction between men and women in the revolutionary forces. So, when the IWM demonstrators vigorously repulsed the provocation, the "IPANA opportunists began their most 'malicious and contemptible' propaganda against HGP (M-L) and IWM 'attack' on 'women and children'."

IWM comrades have never accused "IPANA" of having attacked their people. IWM has justly accused "IPANA" of organizing this provocation which IWM resolutely repulsed. The "unit" in Montreal has even difficulty getting this much straight. This "resolution" stating that IWM changed its story is altogether wrong and further exposes the trickster nature of these individuals. TO BE CONTINUED
