DEFEND THE LIFE OF THE POLITICAL PRISONERS AND PRISONERS OF WAR OF THE NAVAL BASE OF CALLAO AND YANAMAYO!  
DEFEND OUR SISTERS AND BROTHERS IN THE CONCENTRATION CAMPS OF PERU!

**In Peru today there are 5000 political prisoners. The majority have been accused of ties to the Communist Party of Peru (PCP) Under the guidance of US imperialism, the authorities in Peru deny prisoners the right to live.**

The prison system is devised to isolate the prisoners and let them slowly die. In the prison of Yanamayo in the province of Puno near the Bolivian border, high in the Andes, conditions rival the Nazi concentration camps of World War 11. There is no water in the cells, no heating, no electricity as temperatures outside vary between -5 to 10 \* C. causing the health of the prisoners to deteriorate. Last November the prisoners presented a list of demands to protect their integrity and democratic rights. They demanded the closure of the prison as little better than a fascist concentration camp. They asked for the closure of the prisons Challapalca and the naval base of Callao where the leader of the PCP Chairman Gonzalo is still in detention. They asked for prisoners to be sent to prisons near their homes so that they can receive visits from their families. They asked for an end to the theft of their food by guards, the right to medical care, the right to work etc.

Last February 6th at 11.30pm guards and police invaded the prison to harass. The prisoners resisted. Next morning police and the army invaded using gas and pointing guns at the faces of the prisoners. One, Carlos Ponce Torres was killed with a bullet to the forehead. It took the police 30 hours to restore their order and release the hostages seized by the prisoners of war

On Feb 7, the comrade prisoners issued a statement, that their iron determination had unmasked the isolation and genocide plans of the fascist authorities backed up by the Yankee imperialists. They restated their determination to pursue the struggle and win victory armed with Marxism-Leninism-Maoism Gonzalo Thought. despite the death threats and the revisionists who hope to promote "peace schemes".

Chairman Gonzalo said, " We are here as children of the people and we are fighting in these trenches, they are also trenches of combat, and we do it because we are Communists! Because here we are defending the interests of the people, the principles of the Party, and the People's War. That is what we do, we are doing it and will continue to do so."

Proletarians of Australia. Now is the time to tell those Peruvian authorities through their Consulates, Embassies, and their Government that we are watching them. We will not stand by and watch our class sisters and brothers starved and frozen to death in a new wave of fascist concentration camps.

The political prisoners and prisoners of war of the Communist Party of Peru extend our revolutionary greeting to the National Proletariat and the Peruvian People; we extend our greeting to the International Proletariat and the Peoples of the world.

We denounce before national and international public opinion the genocide plans of yesterday and today (October 4, 1985 in Lurigancho prison; June 19, 1986 in the prisons of Frontón, Lurigancho and Callao; May 6, 7, 8, and 9, 1992 in Canto Grande prison; February 7, 2000 in Yanamayo prison; etc.), the war without prisoners carried forward by the Peruvian state, along with its the fascist, genocidal and country-selling government and the puppet Fujimori who heads it up. These are genocidal plans carried out by the genocidal armed forces and police forces, all under the advisement and endorsement of imperialism, principally Yankee, strengthening their low-intensity warfare. One of their accomplices is the International Red Cross.

On February 6, at 11:30 at night, at pavilion 4 of Yanamayo prison, the genocidal police forces with their special force DINOES made their incursion to carry out their infamous genocide, assassinating a prisoner of war and leaving dozens with bullet wounds, ending this incursion with a massacre at 5:00 AM on the 7th. They dreamt of a devastating, decisive blow, that would carry forward the crushing of the struggle of the prisoners of war; the iron resistance of the prisoners of war is unmasking the fascist concentration camps of the navy base of Yanamayo and Challapalca, of these plans of greater isolation and genocide, and it is in defense of the people's rights, the revolution and our own lives, principally to Defend the Life of Chairman Gonzalo who has found himself in greater isolation since 1992, in which the fascist dictatorship, principally Yankee, is carrying out counterrevolutionary hoaxes against Chairman Gonzalo.

This infamous genocide, which is perpetrated by the police forces by government mandate under the command of Colonel Altamirano Flores-we say by government mandate because since September 1999 this prison has been under the direct control of a commission of the Ministry of the Interior sent from Lima-have acted with blind hatred against the best sons of the people and have crashed against the unbreakable resistance of comrades, combatants and masses, that raising ideology, valor and heroism to its peak and reaffirming revolutionary violence, make a great example for the Peruvian people and the peoples of the world.

We unmask that infamous and counterrevolutionary black vomit that

defends Fujimori's genocide, saying: "the inmate Carlos Ponce was assassinated by the inmates themselves, because he attacked the official's order...", with this farce they pretend to cover up the genocidal politics of the fascist dictatorship; the prisoner of war Carlos Ponce, today a hero of the people, an example of giving one's life for the Party and the revolution, was assassinated by the genocidal police forces with a shot to the face from a meter away.

Nevertheless the fascist dictatorship says: "in the prisons, the human rights of the prisoners are respected...", "pacification", but in deeds they show that with their genocidal infamy they continue bloodying our people, that the armed forces and Fujimori government have been the most genocidal and country-selling to date. This rotten and sinister banner of human rights does not have nor will it have anything new to offer. The human rights that they hold up are the rights of imperialism, of the bourgeoisie and world reaction. It has been shown that the armed forces, police and Fujimori's government don't respect the most elementary of the so-called human rights. As such we cannot permit that they seek to throw dirt in our eyes, we do not permit that they lull our consciences with rotten and sinister banners of human rights, pacification, etc. We also unmask that so-called "defender of the people" who doesn't make them respect nor fulfils what the bourgeois constitution grants him, and who furthermore was warned (July 1999) that the fascist dictatorship was preparing its genocide against the prisoners of war, before which this defender of the people didn't pronounce himself. Then we can say that this "defender" is a worshipper of these sinister plans, he is a knife in the people and an agent of the fascist dictatorship.

In its unchecked and shameless fascism, the fascist dictatorship prohibits, here in this concentration camp, the delivery of the newspapers La Republica and Liberación "because they are subversive"; since then they restrict and they prohibit the right to education and culture.

We also unmask all types of opportunists and revisionists, principally the black heads of the revisionist and capitulationist Right Opportunist Line that raise up a peace accord, that loudly demand amnesty and enlistment and furthermore traffic with the prestige and known ascendancy of Chairman Gonzalo and the Communist Party of Peru, imputing that he is asking for a peace accord. Furthermore, these gentlemen have never done anything for that which they frequently claim to defend: "the presentation of Chairman Gonzalo", nor do they defend the rights of the prisoners of war; but today, with the repercussion of the struggles of the prisoners of war of the Communist Party of Peru, they seek to shamelessly traffic and climb on top of the shed blood to achieve some little thing on their road of amnesty and enlistment. We say that the omnipotent Marxist-Leninist-Maoist, Gonzalo Thought People's War, will sweep away and convert imperialism, reaction and all types of revisionists into a few black ashes.

Finally, the prisoners of war at the cost of their own lives have conquered a grand political, military and moral triumph for the Party and the Revolution, with repercussions in the country and the world;

persisting in combating, mobilizing and producing; we will transform these sordid dungeons of reaction into Shining Trenches of Combat. We reaffirm in continuing to conquer victories, successes and winning battles from beyond death, always guiding ourselves by Marxism-Leninism-Maoism, Gonzalo Thought, led by the PCP and offering our lives for the Party and the Revolution.
