ROBLEM UP TO CONTIGRESS BODY

Committee Meeting Called by Untermann: Report Ready Sunday; Delegates Gather

BY J. L. ENGDAHL

Joe Wanhope of New York, manag ing editor of Wilshire's Magazine, plucked the distinction of being the first delegate to the national congress to arrive in the city from the other

expected early arrivals, by slipping into town late Thursday.

He immediately began looking for Ernest Untermann, chairman of the im-migration committee, the first meeting of which had been called for the day Traveling seems to have been better from the Atlantic coast, however, with Untermann not arriving until yester-day from California.

To Issue Immediate Call

"I will call the immigration commit-tee together immediately," said Unter-

tee together immediately," said Untermann. "I have my own ideas on the subject, but I shall have to confer with the other members of the committee before we can get together on a report. It is probable that there will be both a majority and minority report.

"The report of the committee will treat of the inmigration question in a general way, giving specific attention, however, to Asiatic immigration, a problem with which this country is peculiarly concerned. So far as I am concerned we will not take orders from the international congress. We have our own problems to solve and we must solve them according to the conditions that confront us."

It is thought, that the immigration question may come before the conventions.

question may come before the conven-tion at the Sunday session, this com-mittee being placed immediately before that on "agricultural problems" in the order of business.

Organizations Meet

With the immigration committee at work studying the problems of how best to deal with the foreigner coming to our shores, the delegates of the foreign speaking Socialist organizations met at the national headquarters to plan methods to help them organize their different people better.

In addition to the motions calling for separate foreign organizations and a

in addition to the motions calling for separate foreign organizations and a better representation in the national congress, already published in the Daily Socialist, the foreign organizations will introduce a motion in the national congress asking that they be given part of the dues to maintain their separate bodies. This motion will be as follows:

(a) That an allowance of 14 cents (a) That an allowance of 1% cents per capita be granted by the national office to the foreign speaking organizations as the amount due them for the dues stamps sold to such organizations.

(b) That every state office shall grant at least 2% cents-for the same nurpose.

grant at least 2½ cents-for the same purpose.

"(c) That all the money due to the state offices be deposited at the national office to the credit of each state office to which they belong.

"(d) That any translator's office be allowed to sell Socialist party due stamps to local branches of its own nationality in every state."

The best way to support the three propositions advanced by the foreign organizations is being considered in the conference being held today.

KILLED: **EXPLOSION** ON WARSHIP FOREST FIRES

German Torpedo Boat S-33 Is a Total Wreck; Press Angered

(United Press Cable.) Hamburg, Germany, May 13.—Five sailors were killed and two mortally injured today by an explosion on board the German torpedo boat S-23, cruising near Haligoland. The vessel will be a total wreck. The cause of the explosion is withheld.

Press Aroused

This is the seventh fatal accident or board vessels in the German navy this year and public and press are clamoring for an official investigation. It is point-ed out that in the English navy, many times as large as the German, there are far fewer accidents and the people want to know what is responsible for the large number of fatalities on board the German ships.

Miss Bonham fainted, causing general coufusion, and when another boat rowed alongside all the occupants of the leaking boat sprang into it. The load was too heavy and the boat sank instantly. Five of the boys reached shore in an exhausted condition and Robert Minnich was drowned in an attempt to rescue Miss Koons.

TURKS BUTCHER REBELS WITH HORRIBLE CRUELT

Troops Who Slay Without Mercy

(United Press Cable.)

Constantinople, May 13.—In revenge for the loss of hundreds of their comrades in the campaign for the suppres-sion of the Albanian revolt, Turkish soldiers are putting to death all rebel prisoners and are butchering the nonombatants found in the undefended

The atrocities, according to today's dispatches, are the worst ever commit-ted on Turkish soil.

By means of superior artillery the froops have driven the rebels from all their strongholds. A guerilla campaign on the part of the rebals is gratting. They have fied to the hills and threaten to prolong the struggle indefinitely. Although there are sixty thousand Turkish soldiers now in Albanis, the commanders have asked for still further reinforcements to rid the entir country of the last vestige of revolt.

BAKERS IN **PUBLIC PLEA**

Union Shows That Clean Bread Is Its Aim in Making Rules

Active war against the West Side Boss Bakers, affiliated with the Master Bakers of Chicago, is to be started as the result of misleading circulars that are being circulated on the West Side by the bosses in their attempt to exter minate the bakers' organization.

This move on the part of the master bakers is the latest in the strike of Pol ish bakers who are affiliated with the Bakers' Local No. 12, and a few from Local 13 and Local 237. The instru ent of the master bakers is Mr. Kvist jan, of Kvistjan's bakery, 1027 Mil-waukee avenue, leader of the twelve

wantee avenue, leader of the twelve other bosses directly concerned.

The statement made by the organized bakers in answer to the misrepresentations of the bosses is as follows:

"To the Public: "The Master Bak-

ers of Chicago' have seen fit to issue a circular, an alleged 'exposure of a plot to force the small bakeries out of plot to force the small bakeries out of business.' The contents of this circular are untrue from beginning to end. They begin by telling you that the union has refused to meet them in conference for the purpose of considering the new contract. We admit this refusal, which was prompted by the fact that every invitation to such a conference was signed by one of the most outspoken scab bosses, who never had any dealings with the union and consequently had no right whatsoever to ask us to confer with him. Stats Attorney of Bureau County Breaks Law to Aid Railroad

Pernicious activity on the part of State's Attorney Leonard M. Eckert of Bureau county, detrimental to the interests of the widows and orphans of Cherry, became further evident yesterday when he came to Cuicago to fight cases against the St. Paul Coal company.

Cases Heard Here

The cases in which the hand of Eckert was seen came up at Judge John Gibbons' court, at the county building, the beneficiaries of which are relatives of Sam, 19 years old, and Alfred Howard, 16 years old, boys who perished in the mine holocaust on November 13.

he mine holocaust on November 12.
Attorney Eckert played a shuttle-cock game whereby he succeeded in settling the cases of the killed boys for which the owners of setting the cases of the stheed boys for \$800 apiece, for which the owners of the mine would otherwise have to pay \$5,000. This in spite of the fact that he is a public official and the statutes for-bid his taking part in private cases. Sam and Alfred Howard are survived by a mother and father and two sisters, nine and thirteen years old respect;

nine and thirteen years old respecti eoy. Eckert was the man of the hour. Mr

and Mrs. Howard have been separated for some time. This Eckert knew, for he had represented Mrs. Howard in one or fwo court actions against her hus-band. He worked on Mrs. Howard to settle the case with the St. Paul Coal company. But she sought to secure full settlement for her loss. Eckert found Mr. Howard an easier mark, and settled the cases with him, paying \$1,60 for the two boys.

Woman Sought Justice

Learning this, Mrs. Howard brought action in Judge Gibbons' court to set aside this settlement. But when she came to the court yesterday she found aside this settlement. But when she came to the court yesterday she found arraigned against her State's Atterney Eckert, representing her husbard, and O'W. Dynes of the legal department of the Chicago, Milwaukee & St. Paul rail, way. She argued that she is miserably supported. The court could not find legal ground for settling aside the judgment in favor of the company paying the \$1,600 to the defendant—Mr. Howeved new Eckert's client.

After the decision was rendered, great secrecy was thrown about the case. An effort was made to keep it out of the newspapers, and none of the papers had even a hint of it. Attorneys when approached were very cauties. The only man who would talk was Judge John Gibbons.

Nothing to Hide

"I have nothing to hide," the judge said to a reporter for the Chicago Daily Socialist. "There was no legal ground for setting aside the judgment," he explained. "The arguments present-ed left no other position for the court to take."

Mr. Howard was not in court. The attorneys fought the case for him. Eckert, assisted by one of the most highly paid attorneys of the railroad company, handled the case with great efficiency. Eckert has acted as claim agent for the mine company in nearly all of the cases that resulted from the destruction of the mine. He had a Pullman car in Cherry where he had the bene-

ficiarles sign away their rights to dam-age claims.

Comparative Fatalities

"Where England has nearly \$00,000 men at work in the mines and suffered a death loss in the years 1899 to 1908 of 10,239 miners, the United States, in the same length of time, working but 550,000, has had 18,775 persons killed in mine diseasers.

"The same comparisons hold true with other countries, for Beighum loses but a fraction over one out of every thousand persons, employed in the mines, while the United States has a death rate of

"There are thirty coal producing states in the Union," continued the miner congressman, "and the bureau of mines will attempt a solution of the new problems which have been brought about by the introduction of machinery which, for instance, creates more dust and cobsequently vastly increases the danger of mine explosions.

Electrical Problems

"Then there are the new electrical problems, the question as to whether a "silent current" is a dangerous factor or not, and andless other problems that only a national bureau can solve. It was impossible to expect that thirty separate states would set up thirty separate bureaus of investigation or that the matter could be left to private corporations whose great care is to protect their dividends rather than human lives. Then there are the new electrical

human lives.
"We have not gotten all that we desired, and no miner knows that better than Representative Nicholis and myself, who have worked for this measure ever since we were elected to the Sixtista congress, but it is a solid beginning and we shall go on making it stronger."

Have Mine Bureaus

England, Germany and France have bureaus of mines and maintain experiment stations where explosives are tested and where safety lamps, rescue appliances, and all other devices for use in mines may be examined. Concurrently with the establishment of mining bureaus, mine conditions began to show the improvements. Safety lumps greatly superior to those previously in use were manufactured as soon as the defects of the earlier forms were pointed out at the experiment stations, and the development of improved forms of rescue appliances, electrical firing devices, and many other means of giving increased safety to mine workers have been inseparably connected with the stimulus given by these bureaus.



One of the largest, if not the largest, is located at Bedford, Indiana-last November five of the largest stone cutting firms in Bedford posted notices that after December 1, they would recognize the National Stone Cutters' association. This organization is an independent union, a rival of the regular Journeymen Stonecutters' union, affiliated with the A. F. of L.

Put Bosses on Record

In order to put the bosses on record and see if they would recognize the regular union, the men asked for a year's contract and a raise in wages. This was refused and consequently the regular union men walked out. In a very short time other trades struck in sympathy, but most remarkable of all was the isrge number of unorganized workers that walked out, and while out became members of the union. Today there are more union men in Bedford than ever before. than ever before.

The contractors, anxious to defeat the men in Bedford, brought all their surplus men to that city, and the union men, taking advantage of the situation, demanded an increase of wages at oth-

demanded an increase of wages at other points and secured it.

The National Stoneculters' union was rapidly disbauding; in fact, it had been absorbed by the regular union in Milwaukee. Pitaburg, Buffalo and Montreal. Seeing that this was likely to happet, in Bedford as forty-eight out of seventy had already been taken into the regular union, the bosses took steps to prevent the final dissolution of the National Stoneculters' union by giving it official recognition and ignoring any demands made by the regular union.

Efforts have been made to import scabs, but in the great majority of cases as soon as the men learned the situation they refused to work. At one time, seventy men were brought from Chicago, and the bosses were so kind and good to the scabs that from the time they left Chicago until they landed in Bedford all they had to cat was an apple and a sandwich in a period of time covering thirty hours. At present all the other trades have gone back to work but the stonecutters are still out and will stay out until they win. Large hulldings in St. Louis and in Portland. 

HEINZE FREED; CALLED ROBBER

In Spite of Prosecution Banker-Copper King Is Acquitted by Jury

New York, May 12.-F. Augustus Heinze, the copper magnate charged with misapplication of the funds of the Mercantile National Bank of New York while president of the institution in 1967, and with over-certifying the cheeks of his brother's firm, Heinze and company, was formally cleared last night of all charges, after a trial lasting three weeks.

A comparison is made between this trial, and the trial and conviction of Charles W. Morse, who was given fifteen years for "bank wrecking," and because he had falled to deposit collairerd. Heinze escaped, on the ground that he had deposited collateral for all the money he had loaned from the bank immersation in the money he had loaned from the bank immersation. for gambling purposes. Heinze's trans-actions were held legal, in spite of the efforts of the prosecution, Heury A. Wise, United States district attorney, compared Mr. Heinze to a burglar who pries open a window and steals money from the hureau drawer. He charged that Heinze had looted the bank and that he still owed the bank \$300,000 in spite of the collateral seemingly valuable but proved to be worthless. Heinze said the trial caused him to lose \$4,000,000.





A Funny Situation

The sanitary district of Chicago includes the city of Chicago. The sanitary district has a vast water power from which it is pro-

The city of Chicago uses great quantities of electricity. The schools of Chicago need electric light, The streets are illuminated by thousands of electric lights. The parks use thousands more.

One would think that plain common sense would dictate that the city of Chicago should use its own power to produce the electricity that it needs, especially when it is admitted by everyone that the drainage board is ready to supply the city at a far lower price than it can procure its power and light elsewhere.

Yet every attempt of the sanitary district to supply electricity to the city of Chicago has met with determined opposition.

This opposition has not stopped at murder when necessary to attain its ends. Neither has anyone ever been punished for murders so committed.

This is not a conundrum, so we will give the answer at once. There is only one reason why the people who occupy the sanitary district are not allowed to sell power to the people who live in the city of Chicago. That reason is the Commonwealth-Edison Electric com-

That company controls Busse and the gang of thieves who run the city government. Hence the opposition to the use of sanitary district electricity for street lighting. Ogden Armour is heavily interested in the electric light and power trust and its allied industries. He controls the school board through his attorney, who is the president of the board. Hence the opposition of the schools to sanitary district electricity.

So the story goes. The people of the city of Chicago have elected the candidates chosen by the parties which are owned by the great capitalist interests. These interests use the government for private

So long as the municipal government of Chicago is the private possession of a few capitalists, those capitalists will object when the people wish to use their own electricity.

Some day the voters will have sense enough to put a party in power that is not interested in maintaining private profit. That is what the voters of Milwaukee have done.

The Battleship Florida

For a moment the United States possesses the largest murder machine in the world. It will not hold this advanced position long. A half dozen other nations are straining to build bigger and more perfect instruments for man-killing.

Today, however, the palm rests with the United States. When the Florida is completed she will be able to hurl more murderous projectiles and destroy more property in a minute than any other piece of mechanism on earth.

Her construction is a measure of the progress that has been made in constructing these instruments of destruction. We are told that with every broadside she will hurl more tons of metal than Dewey's whole fleet could throw when he sailed into Manila bay in

That was twelve years ago, and every ship in Dewey's fleet is now but so much junk. A ship which can be whipped is junk. A ship which cannot injure another vessel is worse than junk. Every increase in the size of ships, every improvement in armor or armament, makes junk out of all previous material.

The Florida created a lot of junk.

The workers of the United States are paying for that junk. They are paying for the ships that make junk of the older vessels.

Suppose the money that has been invested in a navy were used

in the building of big, beautiful, safe excursion steamers to sail out of the harbors of the great cities on the ocean and the inland lakes. It would be possible to take every sick child and every worn-out mother dust which made the other passengers for a good, long vacation trip that would save thousands of lives each in the coach puff and sneeze and gasp

We believe that would be a better way to spend the money.

A Real World Movement

Roosevelt talked in Berlin on "The World Movement." He displayed his knowledge of ancient and modern bistory and proved that he is fully capable of passing an average high school examination on those subjects.

Well, let's see just what it amounts to. There is no need to question that if labor went into one of the old parties, AS A UNIT, it might capture that party.

We will even admit that if working men were to work together in one body and decide on their plans in advance they could enter one of the old party

machines and take possession of it.

Of course, the plan presents infinite difficulties; it demands secrecy, absolute loyalty and the harmonizing of Republican and Democratic working men.

It means, furthermore, that labor must be practically a unit in plan and in action before undertaking this work. But suppose all this were possible, what

A party is a collection of men joined together voluntarily to seek certain ends.

Some of the hardest workers expect to be rewarded by jobs; others expect to be rewarded by corporation money; still others are satisfied with the honor that comes from occupying a prominent public position.

And we know that neither the Democratic nor Republican party lives on air, They spend millions of dollars in political campaigns, and that money comes

And we are dead sure that it does not come from the common voters.

In fact, we know that money comes from corporations, franchise thieves, proected industries, manufacturers' associations and other similar organizations of

And we know that this money makes the mare go, keeps the machine oiled, buys votes and supplies bread to the henchmen.

We know also that the support these old political machines get from the newspapers is paid for unless the newspapers are owned by the same men that

Now, when powerful corporations buy a political machine they buy merely a voluntary association of individuals. They buy that association's good will, and beyond that, nothing.

When, therefore, a body of earnest men endeavor to capture an old party

machine, what are they after?

They are trying to capture a collection of crooks, who have been seiling themselves at every election to the highest bidder.

They are trying to capture, against their will, a band of political desperadoes that are willing to stuff ballot boxes, buy votes, rob the public treasury or de almost any other thing to keep in power.

If one set out to capture Tammany Hall he would find that it is not a fortress or a bank, or a grocery store.

He would discover that a political machine is not a physical, tangible thing like a pearl necklace. You can't steal it and put it into your pocket and get

like a pearl necklace.
