Statement From His Los Angeles Cell.

He charges an agent of the steel trust with having offered him a bribe in the form of a salary to betray his trust while he was secretary of the Struc-tural Iron Workers' union.

Gives No Interviews

Since he has been in jail here there have been no authentic interviews with McNamara. He has talked to no newspaper representatives, has constantly setused to see any one save his attorneys. Though still refusing to be interviewed he sent out from his cell today the following authorized statement, prepared at the request of the Daily Socialist's representative.

it was my services which this corporation desired, or whether it was its obfact to corrupt my own organization, I
soffered to resign my position and go to
work for the Steel Corporation at a salarry of \$150 per month.

Offer Declined

"This offer, however, was promptly declined, and I was openly told that I could be of no use to the Steel Corporation unless I remained an official of the International Association of Bridge and Structural Iron Workers.

"This is but a sample of the many personal experiences of this nature which I have bad, and which I know other men, occurring similar positions

other men, occupying similar positions to my own have also had. In spite of all the temptations which have been placed in my path, I have sought to lead an honest and upright life, and I believe I can truthfully say that I cannot honestly be accused of preaching any doctrine except that of compliance with the faw.

"In other words, I have always been

interest of the ruling class is proved by the dissenting opinion of Justice Har-ian, in the recent Standard Oil case. Harlan, who has served thirty-four years as a member of the highest reterms of the highest tribunal of the land, said:

How They Do It

When men of vast interests are con erned, and they cannot get lawmaker cerned, and they cannot get lawmakers to enact amendments to construe the law as they desire, they spare no effort to get some case before the courts in an effort to have the courts construe the constitution and the statute to mean what they want them to mean. "The opinion today means that the courts may by mere judicial construction amend the constitution of the United States and the statutory laws."

Considering that this statement comes

Considering that this statement comes rom the oldest member of the Supreme Court, both in years and in service, it must be admitted by all fair-minded men that the Socialist position is one of the gravest importance. It was never intended by the founders of this government that the judicial branch should eroach upon the rights of the legislative and executive branches

New Constitution Necessary

On the other hand the constitution while declaring that the appellate juris-diction of the Supreme Court should be defined by congress, does not specif-ically prohibit the courts from assum-ing rights and privileges by custom or practice. To have such a limitation and to otherwise protect the rights of the people, a new constitution is necessary. It is therefore necessary to imme-diately inaugurate a nation-wide campaign in favor of the Berger resolution providing for the calling of a constitu-tional convention. Socialists should take advantage of Harlan's opinion and use it for the purpose of creating agi-tation in favor of a new constitution. will continue to amend the laws in the interests of the exploiting class

Hardie Thinks That British Government Should Expend Big Sums.

London, May 18.--Keir Hardie wants the English government to spend last year's treasury surplus of about \$25,-000,000 on the promotion of universal

Chancellor of the Exchequer Lloyd George's plan is to devote it to a broadening of the old-age pension system, to improvement of the labor exchanges and to other sociological experiments. Hardie argues that no sociological experiment will do the masses more good than making war impossible.

Big War Expenditures

If England's current year's expen liture of \$375,000,000 on its army and navy were divided up among the people, Hardie points out, it would give an ple, Hardie points out, it would give an increased wage of \$1 weekly to each man, woman and child in Great Britain. For a country where a more or less skilled workman's wage does not exceed \$7.50 weekly, Hardie thinks this extra \$1 would be a pretty substantial increase. He adds that the more this expenditure grows the harder it will be to get social reform.

It is further stated that the committee has been unable to induce persons having such information voluntarily to appear and testify before the committee because information voluntarily to appear and testify before the committee because they lived outside the jurisdiction of the state of Illinois.

Capitalism is playing ducks and rakes with the health of our children A hasty, cursory glance through the naves and walks of the Child Welfare Exhibit proves that to the immediate satisfaction of every thinking mind.

Isolated daets injected here and ther among the exhibits made by the settlements, the churches, philanthropic and educational institutions, etc., prove to me conclusively that one or more so-callstically-minded persons were at work among all that fashionable rabble to scatter the seeds of thought for the seeds to thought for the

to scatter the seeds of thought for the people to take home to brood over.

Vistors Would Shudder

If all these isolated facts could or would have been gathered in one spot, classified and their real meaning shows in their utter makedness the visitors would have shuddered at their ghastli-

ness.

These things are horrible. How can they be still possible in the twentleth century in the foremost American city? (New York, you know, is a cosmopolitan and in no sense an American city.)

Here are a few indicatory seeds those progressive, thoughtful minds. have

The Chicago department of health has a very creditable exhibit, which in a startling manner shows the mortality of infants.

One wall of the exhibit is covered with thousands of tiny porcelain dolls to show the harvest of death—how 3,500 babies under one year die every year.

And in the center of the exhibit is a mechanical contrivance around which rotates a procession of baby figures. Suspended over the center of the front hangs a ceythe that mows off the bead of every fourth born baby that passes. People sometimes stand a long while before this appalling spectacle.

Lowest Among Jews

The attendant explains that the in fantile death rate is lowest among th Jewish race, because of the greater care and affection given the bables, and highest among the Italians and Poles. This, of course, explains the further fact why the Italian and Polish children that do grow up are physically stronger and healthler than the Jewish

Adverse conditions eliminate the weaker children among the Italians and Poles, allowing only the stronger to survive. It is the survival of the phyically strongest under our capitalists

limpure air and impure food diseases are given as the predominating manage of this tremendous infant mortality.

It is a remarkable fact that employes in the textile mills having an American training are becoming fewer each year—they are being gradually displaced by Poles, Italians and Greeks. The employers usually have two, if not more, nationalities employed, and generally manage to engender more or less national dislike between them. I find that among the Poles, or rather their priests and leaders, there is no opposition to the organized labor movement, but there is a determined effort to retain their national customs, religion and language, and to obtain political recognition. In other words, they do not want to become assimilated, but want to form their own colonies."





No child can be well born if the parents suffer under adverse conditions.

- Lack of nutrition.
- Overwork.
- Fatigue.
- Worry. Excitement. Poverty.

Today many parents suffer from some or all of these conditions. That means that children cannot be well born. The sad fact is proved by the vice and crime, the wretchedness and degradation which flow in an ever-ending black stream through the land.

Poverty, which is the mother of the other adverse conditions named, is chronic and, under the present organization of society, is the inevitable and unescapable lot of the many.

What is the cause of material poverty? Is it due to the niggardliness of nature, to the barrenness of her resources, to the lack of water, soil, air, sunshine, coal, iron, wood and stone? Or if nature does furnish sufficient raw material to feed, clothe and house all the children of men, is it man's incapacity to convert nature's raw material into things of use, comfort and beauty that causes want and condemns a large part of the race to degrading poverty or the fear

Science, industry, commerce and common sense unite in declaring that it is not the niggardliness of nature nor man's inability to produce that cause poverty.

There is enough for all. With each mouth comes two hands, and back of these hands are the achievements of ages in science, invention, art and organization.

The wealth-producting power of labor is unlimited. The problem of poverty is not a problem in production, although present methods are desperately wasteful, but of distribution.

It is not so much a matter of inventions and scientific discoveries of new forces and treasures, but rather of a new, a scientific and equitable method of distribution.

Production has become social, but distribution is private and

We have abolished the sickle and flail, the ox cart and the wooden plow, but we still retain private land rent.

We no longer barter commodities for commodities. We have 'world's credit," "world's exchanges" and universal standards of

walue, but we still retain interest,

We have vast public warehouses and factories, but they are
privately owned and we pay tribute—profit we call it—to the lordings who own them.

Thus we part with a large portion of the wealth we create. We pile it up in great fortunes and create within the public state vast private estates which absorb the earnings of the many and cause the poverty of which we complain.

For every millionaire there must be a thousand paupers, but we continue to make laws that favor the millionaire and add to his millions without productive effort on his part or without rendering

vice to the public in exchange for his income. The private ownership of the means of production places the non-owning class at the mercy of the owning class and keeps them on the line of a bare subsistence. Accident or illness pushes individuals below this line, while economic disturbances, due to the unscientific character of the system, precipitate entire communities and classes into helpless poverty.

Her love goes out to all, limited only by inherited and acquired



Resario Curcie is an Italian and is a track laborer. He earns his living by working for from \$1.10 ') \$1.25 a day repairing the roadbeds of the rathroad company, and the safety of railroad transportation depends upon the work of

The I. C. Ry. Co. in Chicago Las . Large eight or ten-story building at Twelfth street and the lake. It owns pretty much all of the lake front. You can go all through the building and you will find the names and titles of men who are officers of the Illinois Central Railway company. This company looks respectable on the surface.

The Yazoo'& Mississippi Valley railway is a corporation, organized under the laws of Mississippi and runs out of Memphis, Tenn. This railroad uses Italians to work upon its tracks.

O. H. Markham of Chicago is president of the Yasoo and of the L. C. Ry. T. J. Poley is general manager of the Yasoo and of the L. C.

W. L. Park of Chicago is vice president of the I. C. and also the Yazoo The auditor of the Yazoo is the auditor of the I. C.

H. B. Brown is the master mechanic of the L C. and of the Yazoo, and is ocated at Memphis, Tenn. In fact, these two railroad companies have in every respect the same officers and agents and the location of the principal office is in the city of Chicago, in the I. C. B. R. office building at Twelfth street and there is no language or indication on the doors of the I. C. By. building to indicate that these gentlemen are officers of a nulroad outside the state of

On the 16th day of November, 1910, Mr. Steinbeck, who is the assistant engineer of both of these companies, called up an Italian labor agency and told them that he wished to hire some track men. Rosario Corcio was among six Italians who were hired. They were promised transportation to Tennessee and, upon finishing their work, return transportation. They were given transportation to Tennessee.

After working fifteen days they were fired and negroes substituted. They asked for return transportation and were refused. Upon arriving at Chicago they commenced suit in the Municipal Court of Chicago against the L C. Ry. Co. for the price of their return transportation.

they commenced suit in the Minnicipal Court of Chicago against the L.C. Ry. Co. for the price of their return transportation.

They had assumed that they were working for the I. C. Ry. Co. A man in the I. C. Ry. Co. 's building hired them. They went south on I. C. transporation. They were informed by the labor agency that they were to be employed by the I. C. Ry. Co. Mr. Steinbeck, in writing to hire these men, used stationery with the name of the I. C. Ry. Co. at the head of it, nothing indicating that they were working for another company being mentioned.

On the trial the I. C. officers came into court and claimed that there was no liability for the reasons that Curcio and the other Italians were hired for the Yazoo & Mississippi Valley Railway company, and that the Italians would have to go back to Tennessee to commence their suit to recover the amount which they paid the I. C. Ry. Co. for return transportation to Chicago from the place where they were discharged.

There was no evidence that these Italians or any other reasonable man would have known that they were employed by anyone else than the I. C. Ry. Co. They have the same officers and it would require the services of Detectives Burns, McFarland, or Finkerton to have ascertained the fact, but the court decided that these men were agents of the Yazoo & Mississippi Valley company, and as such the I. C. By. Co. could not be held responsible.

The decision was according to law. The I. C. Ry. Co. permits its officers from the president down to be efficers of the Yazoo company, to make contracts apparently for the I. C. By. Co., and when sued to claim that they are agents of another company and the lawyer of the I. C. By. Co. comes into court representing the Yazoo company, with this plea, and although we are not criticising the court we marvel at the ingenious deception of the railroad company. It is a cute, cunning and smart trick.

We really suggest that there is only one thing overlooked by this company or two companies. Is it not possible that they ca
