Labor Hating Crowd Loses Major-
ity—Fred C. Wheeler,
Socialist, in City Council.

Los Angeles—Police Judge H. H.
Rose was elected Mayor of Los
Angeles by a majority of 8,828 over
John W. Shank. The total number
of votes cast for mayor was 45,864,
an extremely light vote. The registra-
tion is about 132,000.

Job Harriman, Socialist candidate
for mayor, at the primary last
month, received 20,453 votes, and
an analysis of yesterday's vote com-
piled today seems to show that this
strength was almost solely thrown
in the support of Rose.

For the first time in the history
of Los Angeles, a Socialist was elect-
ed to the council, or, in fact, to any
city office.

Fred C. Wheeler, a leading union
labor officer, claims this honor. The
Socialist's candidate for city attorney
C. O. Morgan, failed by 25,000 votes
of being elected.

Substantive issues thronged the
streets last night and early today to
cheer the overthrow of the "Good
Government" organization, which
has been in the ascendant in city
politics since the recall of Mayor
Harpur five years ago.

Shenly was the candidate of the
labor hating crowd, dominated by
the notorious Otis of the Times, and
consequently his defeat caused great
rejoicing among the workers.

KRYZCKI ADVOCATES MUNICIPAL ICE PLANT

"We should make it possible for
