

"A Wonderful Book."

The Firm Foundation says on advertising W. F. Lemmons' book, "Evils of Socialism." The F. F. calls it a wonderful book.

It depends on the point of view taken as to whether it is regarded as a wonderful. Looked at from the standpoint of truth and fact it is a wonderful batch of villanous lies. Judged from the standpoint of intelligence it is the product of a very stupid jassack.

Take an example or two, to judge it from the standpoint of facts.

Rebel in his book, "Women Under Socialism," quotes the words of ancient times to show the idea and practices regarding marriage in the distant past. Among these old myths was one of a god who married his own daughter, and others equally disgusting.

Two Socialists only, fifty-eight critics, reporters, and bull moose. Lemmons says on this affair and says that it was a Socialist "con dinner" given "to show facts which will be un-far-Socialism."

Things will be un-far-Socialism.

Look at these facts:

1. Only two Socialists in that gathering.

2. The name "Metropolitan Society" shows that the Socialist party had nothing to do with it. Socialist organizations are called "leagues." But Lemmons says that affair to charge "nigger equality" on the Socialist party.

8. That the two capitalist editors named by Lemmons promptly entered denials and gave the whole story in their papers next day.
