WASHINGTON. Feb. 12.—Government censorship of Alaskan railroads and coal 'mines and territorial home rule there, with the initiative, referendum and recall, was urged by William E. Smythe, author and coaservationist, before the House Territories Committee today.

"At the moment when the country is dismayed by the power of monopoly it is proposed to create a new monopoly of fuel and transportation." Smythe declared.



Lecturing in London recently at the Steel and Kingsway Theater on Maxim Gorky Stoughton. and his work, Mr. George Calderon said: "Gorky's success was first made with the public, not with the critics. A new age was coming, yet its Ideal was wanting. First unconsciously, then man as he saw him, with all the virtues which the coming age needed. He loved the world and life intensely, and he put into the coming man the he admired in naturestrength, patience, beauty, and courage. . . Gorky's love of strength explains the fact that his morality is our immorality, and in time the strong woman, the mother of the future came to reinforce in his work his favorite strong man, and to commit any crimes for the sake of strength future generations. His ideals do erts. include institutions; he is not a St. Socialist, nor interested in economics. His ideals are health, love of work. freedom, individualism, youth, and simplicity; his hate is for estaetics. pure science, jesters, gentry, alms-giving. Yet he is not a follower of Nietzsche. His attitude was the same before he could have read Nietzsche and that nervous aristocrat combined in himself two qualities which Gorky detested. The truth is that in all ages of weak men the strong-man philosophy obtained; and it is never the strong man, but the small and mud-dled man who produces clear thought. So far Gorky's ideals were all nega-tive; his were the materialistic ideals of the workingman; and he has put forward no new light to replace hatred than by love; and he falls of the highest art because he caricatures the detested gentry, instant the highest art because he caricature, the detested gentry, instead of draw ing typical characters and, like Tchekoff, looking with pity on both sides."

Nothing is gained in this way. It will only hurt the cause in the minds of thoughtful people. ment against a portion of their fellow human beings which is absolutely the worst thing that could possibly be done


